Call to Order

Chair Tonks called the meeting to order at 10:05 AM.

Public Comment

Ms. Brooke Anderson gave public comment concerning Vanguard Academy's lack of diversity in only ever enrolling white students.

Board Chair Report

Chair Tonks congratulated Member Moss for winning his election to the Utah State Board of Education and discussed the impact of mentoring matters to our community.

Executive Director Report

Executive Director Lambert discussed results of director survey about how they are handling the pandemic, being in the process of hiring two additional staff members known as "portfolio managers," and introduced the SCSB's news employee, Financial Compliance Auditor Smriti Dhakal.

<u>Teacher Spotlight – Teaching Excellence During the Pandemic</u>

Kerrie Upeniecks, Beehive Science & Technology Academy

Ms. Carrie Miller (Ed Direction) presented on Utah Charter Seminar participant feedback results, analysis of student proficiency and growth data, inviting multiple schools to nominate their teachers amidst the pandemic this year, then turned the time over to Ms. Kerrie Upeniecks who spoke on applying so she could help her fellow teachers which in turn would help students.

Board Policy Amendment

Review of Facilities Contracts or Financing Agreements for Charter Schools Draft (3)

Mr. Stewart Okobia provided a history of crafting this policy and how public comments have shaped it.

Member Phillips mentioned issue with the word "approved" attesting that there is no agreement to review until the local board approves their agreement and suggested "before final approval" to suggest a preliminary approval has taken place. The board discussed potential delays to the schools.

Member Phillips moved, and Member Smith seconded, "to adopt the Review of Facilities Contracts or Financing Agreements for Charter Schools policy with the very minor revision of stating 'before it is approved' to 'before it is given final approval." Probation Status Update and Possible Action Under UCA 53G-5-501(2)

Canyon Grove Academy

Vice Chair Tonks declared a perceived conflict of interest as she is the director of Mountain Heights Academy.

Mr. William Evans discussed the history of Canyon Grove Academy (CGA)'s material breach of their Charter Agreement and the need for CGA to remove its distance program.

Mr. Greg Connell presented on homeschooling occurring at CGA, historical timeline, conversations held with the school, and the schools model.

Video evidence of the school marketing homeschool was shown.

Representatives of CGA discussed not being a homeschool, but blended; having all teachers licensed and in CACTUS; providing student directed/teacher supported studies, parent role, dual enrollment, how the WPU works, FTE, qualifications of instructors, what instruction looks like for students, and the purpose of actors.

Motion

Member Moss moved to "leave them (Canyon Grove Academy) on Probation, and consider assigning a mentor that could help, and that we refer their proposed amendment, which has not been reviewed in detail since August, to the Authorizing and Amendment Committee for review and report to the board next month." This motion received no second and was amended below:
