





In IECHS' Re-Charting from District documents, IECHS requested the ability to enter into articulation agreements with neighboring charter schools which do not have a high-school component. However, as we typically do not maintain a wait list, all students who desired admission were able to attend. However, for this school year, IECHS maintained a wait list and it is anticipated that a wait list will be the norm moving forward. Thus an articulation agreement should be in place. As Early Light Academy is focused on college prep and IECHS is an early college high school, a relationship between the two schools is in the students' best interests. By providing enrollment preference to students from Early Light Academy, who are promoting out of a small, college focused charter school, the students will be able to attend a high school with a similar culture and experience. Siblings of current and previously graduated students of Itineris will retain higher preference. As permitted by statute, IECHS will also give enrollment preference to board member children and grandchildren and children of employees. This Articulation Agreement giving enrollment preference to students from Early Light Academy will stay in place as long as IECH does not offer 9th grade and will automatically renew annually until one school requests the agreement to end.


