This waiver is necessary to seek exception from the 180 day rule while maintaining the 990 hours. We would like to maintain a Monday - Thursday school week with every other Friday being a day for students to come in and work on credit recovery. Fridays will also serve as a day for large scale farm projects, field trips, community outreach and any other opportunities we can make available for students. We have a high number of students that come to Roots very credit deficient. Having classes on Monday - Thursday only will give students the opportunity to focus on their current classes. It will then give them Friday to focus on completing their necessary credit recovery. We strive to create more hands on learning and authentic spaces for students to learn, Friday will allow students to engage and receive more help from teachers rather than completing a packet or an online course. These Fridays will also provide opportunities for internships, college visits and job searches, we want students to realize that their opportunities are endless. Truancy being another concern and Fridays being a lower attendance day we feel like it will help students not miss important content if they are here for the Monday-Thursday. Fridays will also provide more time for staff to do home visits to communicate with students that are not attending regularly to better understand what is keeping them from attending.
